Job Context: Social Assistance and Rehabilitation for the Physically Vulnerable (SARPV) is a non-government, non-political, Bangladeshi organization providing humanitarian support to the Rohingya people at Bhasan Char. As part of its Health & Nutrition interventions in support with WFP & UNHCR, SARPV is going to implement "Integrated nutrition intervention for Rohingya refugees living in Bhasan Char" project from 1stJanuary 2023.

Job Responsibilities:

Overall Objective:

CFM Assistant is responsible for assisting in day-to-day implementation of the Community Feedback and Response Mechanism. Main responsibilities are mostly related to Accountability of Affected People (AAP) and include documentation of feedback and complaints, routine recordkeeping, and reporting. The position requires the ability to work in the field level with a multi-sectorial program team and to interact effectively with a wide variety of community members. This position is based on Bhasan Char camp level at Hatiya, Noakhali.

Key Job Responsibilities:

- ⇒ Work with program staff and beneficiaries to develop structure and methods for managing the complaints and feedback in the field as well as maintaining the integrity of information received
- ⇒ Management of CFM database by ensuring proper documentation and aggregation
- $\Rightarrow\;$ Ensure the collection of quality complain and feedback across the response
- \Rightarrow Interface and support programme team members, support programme coordination and policy engagement.
- ⇒ Analyze and prioritize the complaints according to its sensitivity
- ⇒ Assist in programme updates for the response management and internal information sharing
- \Rightarrow Assist in data collection processes if needed
- ⇒ Assist to conduct AAP sessions and monitoring
- $\Rightarrow \;$ Assist with implementation of programme evaluations (data collection)
- \Rightarrow Support in conducting assessments as needed
- ⇒ Assist in handling, documenting, confidentiality and security of all informational resource related to feedback and complaints from beneficiaries
- ⇒ Support Complaints and Feedback Mechanism, including communicating responses to complainants; liaise with management and operations to ensure prompt follow-up on feedback and complaints received
- \Rightarrow Work with field teams to collect information on potential case studies and success stories
- \Rightarrow Other duties as directed.
